AGENCY & STAFF REPORTS:

NARD Report: Gene Kelly reported that NARD had a successful conference. There were no resolutions this year. The Association Board met following the conference and reviewed the audit for the general operating and foundation accounts. A motion was made and passed to pay an additional \$100,000 on the building loan from the Risk Pool funds. This can only happen when the equity in the Risk Pool is at 4 million dollars and right now it is at \$7.1 million. The Foundation approved requests of \$1,000 to the Nebraska LEAD program, \$5,000 to the Longitude 103 project and \$500 to co-sponsor the North American Invasive Species Management Association Conference. Following the board meeting the Risk Pool meeting was held. The Risk Pool audit was approved and the financial look good. The Pool did have a net profit of \$2.3 million for the fiscal year. Jennifer Swanson has a new job description since she is no longer partially funded by NDEE. She will continue to coordinate the projects she worked with before but will also be involved with working groups, organizations, the private sector and other state and federal agencies that share the goal of improving water quality. The Public Service Commission is having a hearing Thursday, the 26th, on the use of precision ag grant funds. Approximately \$500,000 is available for water management tools that facilitate judicious use of water resources. NRDs aren't eligible but producers, agronomists and cooperatives are eligible to apply.

1. NARD Fall Conference Update: Roy Stewart noted that he attended the conference and was recognized for 40 years of service.

DNR Report: No Report from Garry Anderson. Dennis Schueth reported that the UENRD needs to update and submit the districts Long Range Plan to the Department. The plan will be updated this month, reviewed and submitted in November.

NRCS Report: Brandon Peterson's report was mailed out to the Directors. Brandon reviewed the EQIP and CSP deadlines of November 17. Holt County will be the host site for the Area 5 range judging competition in 2024. The NRCS is still operating on a continuing resolution until November 17. Funding for certain things will be restricted until a fully funded budget has been passed. Brandon reviewed the year end program totals with the Board. The EQIP program had 35 contracts for 18,847 acres with a costshare of \$1,301,159. In the BGMA, NWQI had 3 contracts treating 615 acres for a total of \$97,509. There were 5 contracts in CSP for 8,683 acres for a total of \$434,557. NRCS also wrote 191 CRP contracts for a total of 55,402 acres.

RC&D Report:

North Central RC&D: Marv Fritz reported that the Highway 12 paper shredding event was held. They are still waiting to hear on the grant for the tire amnesty event to be held in conjunction with the MNNRD. He also reported that Kim will be stepping down from her position with the RC&D as well as their treasurer. Kim will stay on to help with the tire amnesty grant and the event itself.

Loup Basin RC&D: No Report. **Northeast RC&D:** No Report.

Information & Education Report: Beth Walsh's report was mailed out in the Director's packets. Beth reported that there have been 3 Expansion of Irrigated Acre applications. Two are completing a pivot with less than 15 acres and the other one is extending the pivot. There will be another application submitted this week with the deadline for signup being October 31.

Water Resources and Other Department Reports: Joslynn VanDerslice's report was mailed out in the Director's packets. Joslynn reported that the annual groundwater nitrate sampling is completed; the Phase III soil sampling locations have been selected; and, the Phase III soil sampling letters have gone out. Static water levels will also be starting within the next week. The Phase II data in Beehive has been turned over and letters for Phase II reports will be generated and sent out to the landowners and operators.

Bazile Management Area: Lisa Lauver's report was mailed out in the director packets. Lisa reported that she has been working on the Bazile Groundwater Management Area plan update and EQIP for the BGMA. There are 12 EQIP contracts currently and she has 8 more cooperators she is planning to meet with. Lisa also thanked Joslynn VanDerslice for all the work she has put in on the plan updates. Dennis Schueth handed out information on the Inflation Reduction Act Climate Smart Core Practices and Facilitation Practices eligible for funding. We need to decide if the organization should pursue a grant targeting some of these practices or chose the practices which would compliment the BGMA plan. The Board also received a copy of the current drafted goals and objectives for the Bazile Groundwater Management Plan.

This is due in part to the Chemigation program no longer being supported by the current fees; and, to encourage Chemigators to keep up their annual renewals.
