AGENCY & STAFF REPORTS:

NARD Report: Gene Kelly reported that the legislative conference went well. The bills concerning natural resources in front of the legislature were discussed. The Nebraska L.E.A.D. program banquet will be March 15th if you wish to go contact Dean or Jeanne at the NARD office. NARD has approved up to \$1350.00 for the EPIC tax study group. The Flexible Savings Account plan was amended and approved in January.

DNR Report: No Report.

NRCS Report: Brandon Peterson's report was mailed out to the Directors. Brandon Peterson reported that the initial EQIP/IRA funds is \$1.1 million. They are about 75% done writing contracts. Received additional \$500,000.00 for EQIP. IRA for the UENRD area will be \$1.6 million. Currently writing contracts for the CRP/IRA's. CRP is ongoing. September 19th will be the date for Holt county range judging. Currently operating under a continuing resolution until March 1st. Farm bill has been extended until September 30. Discussion was held on source water protection position and wellhead protection areas. After discussion, the UENRD is not currently interested in funding a source water protection area position since an agronomist position has been opened in the O'Neill NRCS office.

RC&D Report:

North Central RC&D: Mary Fritz reported the tire recycling will be April 1st through the 3rd in Newport.

Loup Basin RC&D: No Report. **Northeast RC&D:** No Report.

Information & Education Report: Beth Walsh's report was mailed out in the Directors packets.

Water Resources Department Reports: Joslynn VanDerslice's report was mailed out in the Directors packets. There are 378 Phase II reports that have not been turned in yet, that includes 165 landowners and 100 operators. She also talked about nitrogen certification. The water conference will be held in Kearney on March 4-5, 2024.

UNL Extension: Amy Timmerman reported on nitrogen certification. She gave chemigation training dates: O'Neill March 7th, Verdigre March 12th, and Ericson March 13th. Staff shall, however, proceed to process all pending applications for certified irrigated irrigated acres. Discussion was then held on the motion.
